- We provide both individual-sized 3 dose kits, and hard sided plastic boxes with 10 or 20 doses (see image to right).

## FORB Initial Supply order at the BCCDC

To receive FORB supplies, sites must be registered with the FORB program. To learn more, visit <https://towardtheheart.com/forb>

### General Notes about Supplies

- The FORB kits and boxes are intended to be refilled. Please do not distribute these kits or discard after use
- Any changes to supplies will be posted on [towardtheheart.com](https://towardtheheart.com)
- Use older supplies first. Remember: First In, First Out (FIFO).
- Naloxone has an expiry window of about 2 years. Please check inventory periodically.
- When a naloxone lot is due to expire, the BCCDC will send out an email with information on how to replace the contents of your kits and boxes. Updates will also be posted on [www.towardtheheart.com](https://www.towardtheheart.com).

- Naloxone ampoules and loose supplies can be ordered to replace the contents of the 10 dose and 20 dose boxes with the [refill order form](#)
- Replacement bottles can be ordered to replace the contents of the blue 3 dose kits—1 replacement bottle can be ordered per kit. Please also order vanish needles and breathing masks

### BCCDC Weekly Processing

- To order supplies to refill the contents of your kit or box, complete the [FORB Refill Supply Order Form](#) and email it to [naloxone@bccdc.ca](mailto:naloxone@bccdc.ca) or fax it to 604-707-2516.
- Please complete all site information fields, as well as indicating any changes to contact information to avoid delays in processing (or email any site updates to [naloxone@bccdc.ca](mailto:naloxone@bccdc.ca) using the [Update Site Details form](#)).
- Orders are processed every Thursday. For timely processing, we recommend submitting your order by Wednesday end-of-day. All orders received after the cut-off time of 11:59 pm on Wednesday will be processed the following week.
- The supplies will be packaged at the BCCDC pharmacy. **Delivery is expected to be up to 10 working days from the Thursday processing date.**
- To avoid disruption of services, plan ahead and place an order before you run out of stock.

### How Much to Order

- We suggest ordering as and when needed.
- For training we recommend ordering 1 syringe, 1 water ampoule, and 1 ampoule breaker per person
- If toxic drug poisonings are rare for your site, we recommend either the 3 dose kit or the 5 dose box.
- The 3 dose kits are ideal for outreach workers.
- A large facility may need more than 1 kit/box.

### BCCDC May Contact You If:

- Your order is unusually large or small
- Your site consistently order kits or boxes rather than replacement supplies
- Your order requests fall outside the FORB program scope (e.g. requests for supplies to distribute to individuals. Please refer to the [THN program information](#))

### Receiving Supplies

- Please check your order upon receipt. Ensure that you have received the correct quantities and that the supplies reach you in good condition.
